The online bids The online may be submitted by due date at [http:#haryanaeprocurement.gov.in](http://haryanaeprocurement.gov.in) whereas sealed bids must be submitted in the office of General Manager, Haryana Forest Development Corporation Ltd, Sohna Road, Forest Complex, Near Courts, Gurugram-1220001 by due date and time i.e. December 01, 2017 at 3.00 pm.
3. The plot has been kept under auction with the due approval from competent authority.
4. The plot is being sold on 'as is where is and what is there is' basis.
5. The documents relating to the plot can be seen in the office of General Manager, Haryana Forest Development Corporation Ltd, Sohna Road, Forest Complex, Near Courts, Gurugram-1220001 between 11:00 AM to 05:00 PM on all working days other than Saturdays, Sundays and holidays. The interested parties may also inspect the plot site in Sector 3, Phase-I in IMT, Bawal, if they desire. The plot number is 162.
6. Biddings and/or purchase of the plot by the NRIs are subject to rules and regulations of Reserve Bank of India and other laws for the time being in force.
7. All the bidders should, prior to the auction, satisfy themselves about the correctness of the description, measurements, boundaries, etc. of the plot. The dimensions of the plot are 100 m (depth from road) x 40 m (front on road) and the plot is free from any kind of encroachment.
8. At present all the dues against the Plot No. 162, Sector-3, Phase-I, IMT, Bawal, Rewari have been paid to HSIIDC and HFDC shall not be responsible for payment of such liabilities/outstanding after the auction/bid is finalized. The extension

- for construction of the building has been granted by HSIIDC and extension fee has been paid by HFDC for one year i.e. upto 30.09.2018.
9. Intending bidders are required to deposit Rs. 30.00 Lakhs (Rupees Thirty lakhs only) as Earnest Money Deposit (EMD) in the form of Demand Draft. This will be refunded to bidders on the conclusion of the auction except the successful bidder.
  10. The successful bidder will be asked to deposit the 25% of the bid amount (including EMD) in the form of crossed cheque in favour of Haryana Forest Development Corporation Ltd. The balance amount of 75% shall be required to be deposited with HFDC within one month of issuance of bid acceptance letter by competent authority of HFDC.
